1. **Club** membership provides insurance and liability coverage for the gym, allows your Boxers to represent the club in shows & tournaments and have a voice & vote in LBC # 38 business. Must have five (5) registered Boxers to have a "Vote". The club representative must be a registered non-athlete. Registration must be done "Online" at [www.usaboxing.org](http://www.usaboxing.org). Fee: **\$ 278** .

2. **Non-athlete** membership provides you with insurance and liability coverage. Allows you to participate as a coach and/ or official. Attendance at a certification clinic is mandatory every 24 months and background screening required every 24 months. Registrations will be done "Online" at [www.usaboxing.org](http://www.usaboxing.org). Click on "**Membership**"; go to "**Non-Athlete**"; go to "**New members**" or "**Renew your membership**"; follow the five steps to register.

Fees: **\$ 113** with background or **\$ 88** if no background needed.

**New** members mail USA Boxing receipt and one passport type photo to receive a "Red Coach" / "Blue Official" passbook to *CN Lopez, 2455 Ocala Ave San Jose, CA 95122*.

**Renewing** members register "Online" and print your membership card. Tape the membership card to the 1<sup>st</sup> page of your passbook.

3. **Athlete** membership provides the Boxer with medical & dental insurance and the privilege to participate in USA Boxing events. Registration will be done "Online" at [www.usaboxing.org](http://www.usaboxing.org). See above for procedures, except go to "**Athlete**". Fee: **\$ 63**.

New athletes need: USA Boxing online receipt, physical exam by an Medical Doctor, copy of birth certificate or passport and two passport type photos OR if renewing: USA Boxing online receipt, physical exam and passbook.

All paperwork must be mailed to *CN Lopez*, 2455 Ocala Ave. San Jose, CA 95122 OR *Celeste King*, 843 35<sup>th</sup> Ave Oakland, CA 94601.

You must send a stamped self addressed envelope with all request for athlete, coach or official passbooks. One first class stamp per passbook. Please make sure that paperwork is complete, signed and legible. Allow 2 weeks for return of passbooks.

Lost or replacement passbooks are: \$ 20.

*“Unpreparedness or incomplete paperwork on your part does not constitute an emergency.”*

4. Sanctions for shows or tournaments can be used as club fundraiser and to showcase your Boxers. Applicant for sanctions must be a registered non-athlete for the Northern California LBC # 38 registered Boxing Club requesting the sanction. *(A “Boxing Club” is a club where athletes go to be trained by a registered USA Boxing coach; all proceeds must be for the betterment and benefit of said Boxing Club.)* Contact- *Lydia Razo*, Chief of Officials, 9194 Sandrine Ct. Sacramento, CA 95829. All sanction forms & monies must be submitted 30 days in advance.
