A registered club is a boxing club that registers with the LBC that governs its geographical location as a club and which agrees to conduct its programs in accordance with and agrees to be bound by the rules and regulations of USA Boxing and meet other registration requirements of USA Boxing. A club is a place where a coach teaches boxers how to box, and pupils come to learn to box from a coach. If there are no boxers, and no coach, then the organization does not qualify as a boxing club.

Club agrees to utilize all event net income for expenses specifically related to the support of amateur boxing and amateur boxing events. (Must check "yes")

Club agrees to provide it's LBC with a completed USA Boxing "Financial Statement for Competition" for any event in which a sanction is granted to said club. Each Event Financial Form shall be submitted to the LBC within 30 days of each sanctioned event. (Must check "yes")

Club agrees to complete and submit the USA Boxing "Club Annual Revenue & Expense Report" to the LBC no later than February 1, of each calendar year. (Must check "yes")
